## Panel Speakers



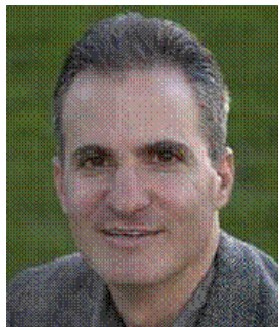
Janice Lachance, Chief Executive Officer of SLA (Special Libraries Association) since 2003, leads the global association representing the interests of 11,000 information and their strategic partners in 75 countries. In that position, she has led the reformulation of SLA's mission, vision and strategic plan, created the online Click University, and expanded SLA's public policy program. She currently leads a multiyear comprehensive research effort to create a shared and evidence-based vision of the future role of the information professional. She serves on the board of the American Society of Association Executives and The Center for Association Leadership and as a Fellow and as Member of the Board of Directors and Executive Committee of the National Academy of Public Administration; she was a U.S. delegate to the United Nations World Summit on the Information Society.



Sue Brewsaugh is a library manager at The Boeing Company, managing the library infrastructure activities for the enterprise. She has managed libraries and related organizations for 20 years. Sue has extensive library experience and has been an adjunct professor for the San Jose School of Library and Information Science for over 15 years. She is active professionally, serving as an officer in the So CA Chapter of SLA as well as the Sci-Tech and Aerospace Divisions. She is also a member of the Conference Board's Information and Research Management Council. In addition to her work in libraries, Sue has worked in Quality and Productivity, Training, Data Management, and was responsible for the scanning of the C-17 drawings and their electronic drawing delivery to the Air Force.



Doris Helfer is Science Librarian and Chair, Technical Services at California State University Northridge. Prior to coming to CSU Northridge in 1996, she worked at AT&T Global Information Solutions, the RAND Corp., and the University of Southern California. She holds a B.A. in Political Science from California State University, Northridge and an M.S.L. from Western Michigan University. She has been very active in SLA, holding many leadership positions including; Chair of the Information Technology, Communications, and Competitive Intelligence Divisions; as well as Southern Calif. Chapter President and numerous other leadership roles. She served on the SLA Board of Directors. She was named an SLA Fellow and is a past winner of the Rose Vermelker Award for Mentorship. She has received numerous awards including the Billie Connor Award for her outstanding contributions to the Southern California Chapter of SLA. She is also an active member of the American Library Association and the California Academic Research Libraries (CARL).



Brian Raphael is assistant director and adjunct assistant professor of law at the USC Gould School of Law Library. Brian specializes in print and electronic legal research and teaches Legal Research at USC Law. His publications include "California Case Law," published in Henke's California Law Guide, 8<sup>th</sup> ed. Brian graduated *summa cum laude* from the University of California, Los Angeles, where he also received his J.D. and M.L.S. He joined USC Law in 1993. Brian is a member of Phi Beta Kappa, the American Association of Law Libraries (AALL) and the Southern California Association of Law Libraries (SCALL). He is currently Vice President/President Elect of SCALL and is also a member of the LexisNexis Law School Advisory Board.
